This supplement (the **Supplement**) constitutes a fourth supplement to and must be read in conjunction with the Base Prospectus dated 24 June 2016, as supplemented by the first supplement dated 12 August 2016, the second supplement dated 4 November 2016 and the third supplement dated 8 March 2017 (the **Base Prospectus**), prepared by Autoroutes du Sud de la France (the **Issuer** or **Autoroutes du Sud de la France** or **ASF**) with respect to the Euro 10,000,000,000 Euro Medium Term Note Programme (the **Programme**). Terms defined in the Base Prospectus have the same meaning when used in this Supplement.

Application has been made to the *Commission de Surveillance du Secteur Financier* (the **CSSF**) in Luxembourg for approval of this Supplement in its capacity as competent authority under the "*loi relative aux prospectus pour valeurs mobilières*" dated 10 July 2005 as amended by the Luxembourg law dated 3 July 2012 (the **Prospectus Law**), which implements Directive 2003/71/EC as amended by Directive 2010/73/EU (the **Prospectus Directive**).

To the best of the knowledge of the Issuer (having taken all reasonable care to ensure that such is the case), the information contained in this Supplement is in accordance with the facts and contains no omission likely to affect its import. The Issuer accepts responsibility for the information contained in this Supplement.

This Supplement has been prepared pursuant to Article 16.1 of the Prospectus Directive and Article 13 of the Prospectus Law for the purposes of inserting on page 93 of the Base Prospectus in the "Recent Developments" section the new information as described below (the **New Information**).

Save as disclosed on page 3 of this Supplement, there has been no material adverse change in the prospects of the Issuer since 31 December 2016.

### **Dividends**

On 5 April 2017, the Shareholders General Meeting approved the consolidated financial statements and the payment of a dividend of  $\epsilon$ 4.94 per share in respect of the year, for a total amount of  $\epsilon$ 1,141,031,324.94. Taking account of the first interim dividend of  $\epsilon$ 0.62 per share paid in September 2016 and the second interim dividend of  $\epsilon$ 3.61 per share paid in December 2016, the remaining final dividend paid in April 2017 was  $\epsilon$ 0.71 per share, an amount of  $\epsilon$ 163,994,380.71."
